Commissioner (P&E) for records.
- 05. All the representations are hereby stand disposed off. No representation regarding transfer and posting in the grade of Superintendent shall be entertained unless officers join their new place of posting.
- 06. The officers transferred from HQs to Division Offices and vice versa should be relieved to join their new place of posting on or before 30.08.2024.
