1. Shri Narayanan C K, 1803, SUMMERSET, CHARKOP VILLAGE, MUMBAI Suburban, 400067 had filed RTI application dated 28.09.2022 under RTI Act, 2005 and received by this office on 03.10.2022.
2. In this connection, the information sought under the RTI application is as under:
 - (i) In view of the **Point (1)**, 10 Officers got promotion from LDC to the Level of Superintendent and completed 4 years as Superintendent in Central GST & Excise, Ahmedabad Zone.
 - (ii) As far as **Pt. (2)** is concerned, out of the above, 6 officers have been given the benefit of MACP.
 - (iii) As per **Point (3)**, 4 Officers were not been given the benefit of MACP.
 - (iv) In view of the **point (4)**, 9 Officers have been given the benefit of NFG and the benefit of 5400 on completion of 4 years as Superintendent. Further, as far as, reasons are concerned, the officers went through different levels of promotion, In 1st Case, some officers working in the grade of LDC were firstly promoted to the grade of UDC, then directly they were promoted to the grade of Inspectors and afterwards Superintendents as mentioned in below table of **Annexure- A**. Simultaneously, in 2nd Case, some officers working in the grade of LDC


were firstly promoted to the grade of UDC, afterwards, they were promoted to the grade of Tax Assistant and then were promoted to the grade of Inspectors and afterwards promoted as Superintendents, the data has been furnished in below table of **Annexure- B**. Further, as required, the details of 4 Officers have been enclosed herewith in the format for the clarity.
