2. In this connection, the point wise information sought under the RTI application is as under:

**(A)** As far as **Point A** is concerned, the details as required are: Office of Principal Chief Commissioner, Central GST & Central Excise, Ahmedabad Zone, 7<sup>th</sup> Floor, GST Bhawan, Ambawadi, Ahmedabad.

**(B)** As far as **Point B** is concerned, the details are: Office of Principal Commissioner, Central GST, Ahmedabad South, GST Bhawan, Ambawadi, Ahmedabad.

**(C)** In view of the **Point C**, as far as Central GST, Ahmedabad South is concerned, as on today, there are total 86 (Executive) Gazetted Officers in the commissionerate and out of these, 21 (Executive) Gazetted Officers are at the same station i.e. Ahmedabad.

**(D)** In view of the **Point D**, as far as Central GST, Ahmedabad South is concerned, as on today, there are total 5 Group B (Non Executive) Gazetted Officers in the commissionerate and out of these, 3 (Executive) Gazetted Officers are at the same station i.e. Ahmedabad.

**(E)** In view of the **Point E**, Group B (Non Executive) Gazetted Officers and Ministerial Gazetted officers are one and the same/ identical.

**(F)** In view of the **Point F**, as far as Central GST, Ahmedabad South is concerned, on today, there are total 45 Ministerial Non-Gazetted Officers in the commissionerate and out of these, 9 Ministerial Non-Gazetted Officers are at the same station i.e. Ahmedabad.

**(G)** In view of the **Point G**, as far as Central GST, Ahmedabad South is concerned, as on today, there are total 24 Group D Officers in the commissionerate and out of these, 24 Group D Officers are at the same station i.e. Ahmedabad.
