The following TERMS and CONDITIONS will be effective during the effective contract period.

1. The service engineer will be made available on daily basis for work pertaining to the website.
2. Service engineer should be computer/IT professional and should have adequate knowledge of hardware, software and protocols of the said uploading work. Details of such person should be provided.
3. In case of any requirement, a senior company official should be assigned the charge of this work for proper technical backing to the service engineer. Details of such person should be provided.
4. The website has to be maintained and updated on daily basis.
5. The update will be carried out within 24 hours of notice from the office. The vendor has to ensure that only content provided and approved by this office is uploaded on the website.
6. Penalty: For not completing task within time limit will be Rs.1000/- per day.
7. No advance payment would be made in any case, however, the invoice for the service will be raised quarterly and payment will be settled after satisfactory completion of each quarter.
8. The company/firm will not have any legal right to proceed against the Department in the event of late payment due to unforeseen reason.
