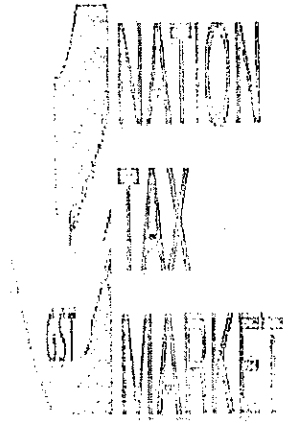

TRADE NOTICE:- 01/2019

Sub: Intimation regarding ACES GST Integration & Data Migration and change of portal name.

All Trade Associations/ Chamber of Commerce and the Members of RAC/PGRC are being informed that Post Roll out of GST w.e.f. 1.7.2017, GST Tax payers are doing all their transactions through the Common Portal (www.gst.gov.in). The taxpayers who deal with Goods attracting levy of Central Excise even after 1.7.2017, continue to access www.aces.gov.in to register, file returns and make payments. The erstwhile Service Tax taxpayers also access www.aces.gov.in, to pay arrears as well to file ST-3 returns late (with applicable penalty /interest etc).

2. One of the components of the CBIC-ACES-GST Backend Application contract is to integrate the existing ACES functionalities of CE & ST into www.cbic.gst.gov.in. The preparatory work to integrate the ACES application with ACES-GST application is completed and ACES applicable (<https://aces.gov.in>) will be migrated to a new ACES-GST application (<https://cgst.gov.in>) shortly. A proposal in this regard is being sent to the Board.


3. During the migration period the ACES application will be shut down for 2 days initially and subsequently will be available in 'READ' only mode. Post Migration tax payers will be directed to <https://cbic-gst.gov.in>

4. It may be noted that Tax payers can continue to make Payments through E-payment through E-payment Menu or directly on EASIEST Portal (<http://cbic.easiest.gov.in>) during the migration period.

5. The actual date of shutdown will be notified by the Board. A detailed Advisory and user manual with screen shots highlighting the navigational paths for log in to transact both by the existing and new tax payers would be released by this office on issue of notification/circular by the Board

6. The Trade Associations/ Chamber of Commerce and the member of the RAC/PGRC are requested to bring this to the notice of their members /constituents.
